1. Sign into Lexis Advance
2. Select *Filters* in the search bar
3. Under *Jurisdiction* and *U.S Federal*, select *All*
4. Under *Category*, select *Cases*
5. Type **Greer 1-800-Flowers** in the search bar and click *Search*



Guess it wasn't a Match.com made in heaven.

In 2010 a number of Match.com customers filed suit against the online dating service for breach of contract, claiming that over half of the profiles belonged to inactive members or were fake. On what date was the complaint filed in the case of *Robinson v. Match.com*?

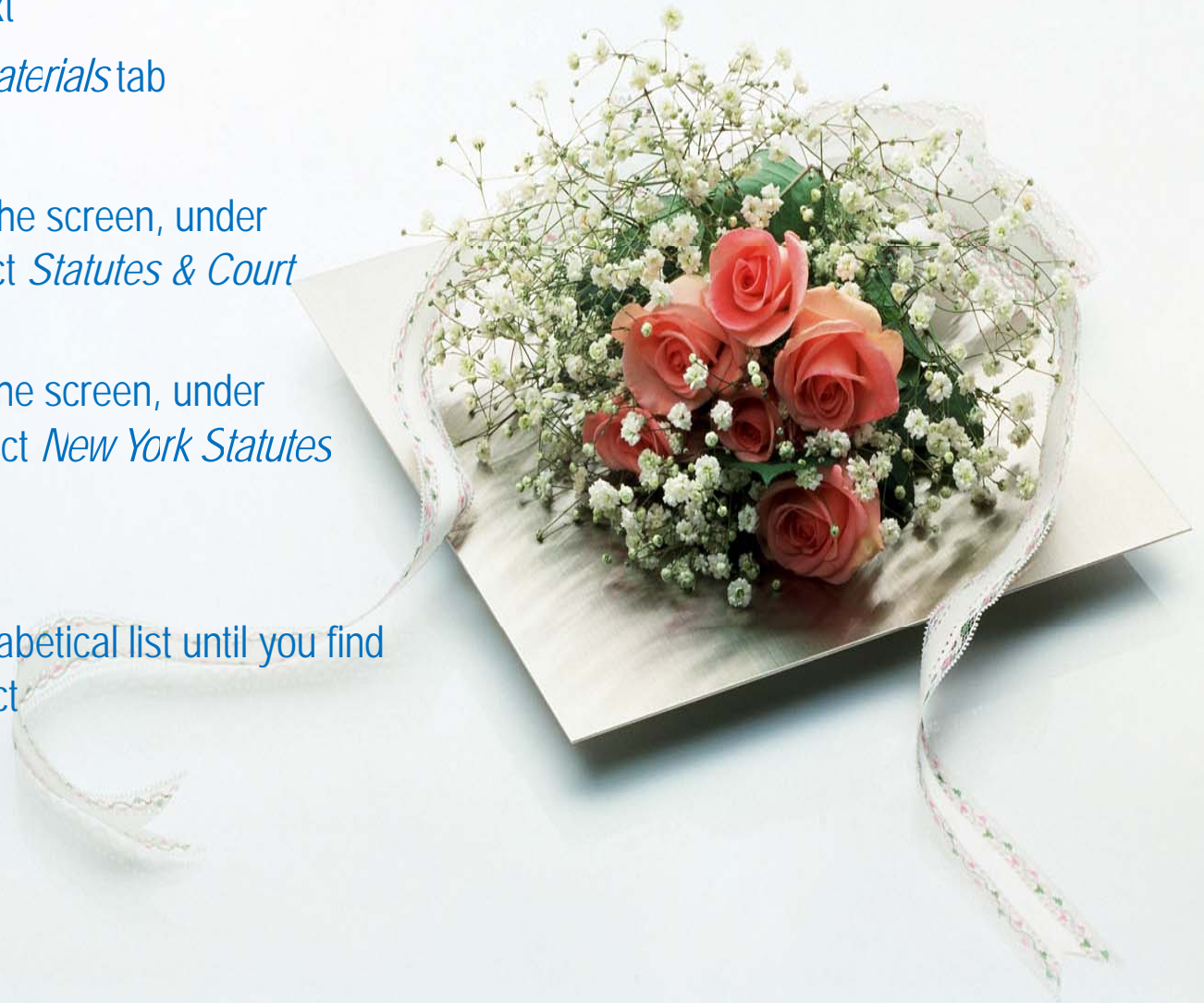
1. Log into Bloomberglaw.com
2. From the *Litigation and Dockets* tab, select *Search Dockets*
3. Click the drop-down menu at the *Browse* button
4. Click on the + button next to *Federal Court Dockets*
5. Click on the + button next to *U.S. District Courts*
6. Scroll down and select *Districts of Texas*
7. Scroll down further on the page to *Party Options* and click the *Multiple Party Entry* tab
8. Enter **Robinson; Match.com**
9. Click the *Single Party Entry* tab
10. Click the button for *All of the Following*
11. Scroll down and click the green Search button
12. Open the docket for the case that results from the search and scroll past the listed parties to the *Docket Proceedings*

Question 4

Into what four sections of New York state law was the Marriage Equality Act codified?

1. Log into WestlawNext
2. Click on the *State Material* tab
3. Select *New York*
4. On the right side of the screen, under *Browse New York*, select *Statutes & Court Rules*
5. On the right side of the screen, under *Tools & Resources*, select *New York Statutes Popular Name Table*
6. Select *Ke-Mo*
7. Scroll down the alphabetical list until you find the Marriage Equality Act



Question 5

What's the title and subject matter of the 2011 New York law that was originally Bill Number A8354? When did the law take effect (month, date and year)?

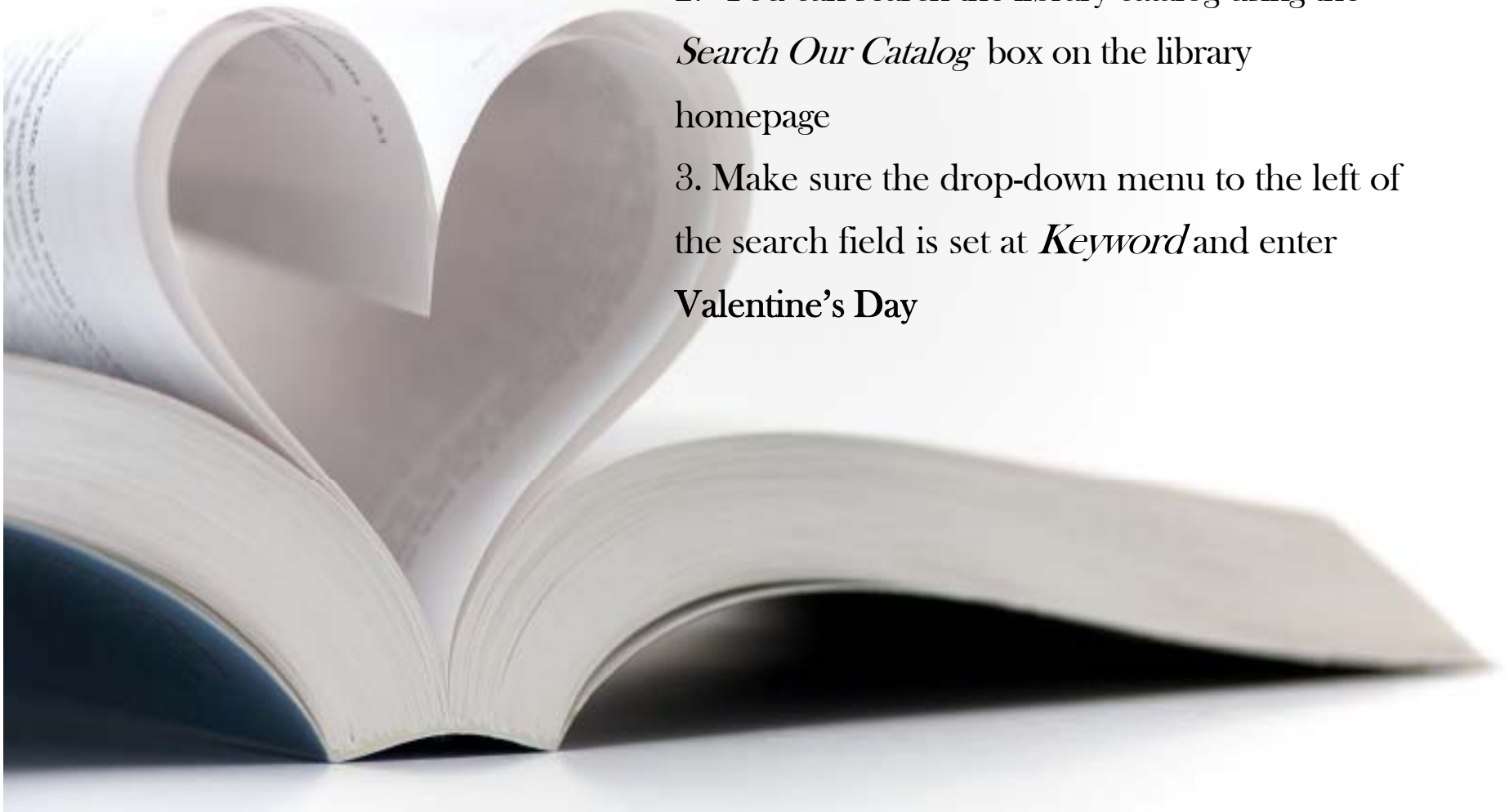
1. Go to <http://public.leginfo.state.ny.us/menuf.cgi>
2. At the top of the screen, uncheck "status" and check "text" and "summary"
3. Select the year 2011 from the drop down menu.
4. In the search box, enter "A8354"
5. Run your search




Question 6

Love in the library (catalog). Find a book in the Mendik Library collection containing “Valentine’s Day” in the title.

1. Go to www.nyls.edu/library
2. You can search the library catalog using the *Search Our Catalog* box on the library homepage
3. Make sure the drop-down menu to the left of the search field is set at *Keyword* and enter **Valentine’s Day**
