Find and cite the opinion that vacated the lawsuit in favor of the chocolate companies.

- Sign into Lexis Advance.
- 2. Select Search: Everything on the search bar.
- 3. Under Jurisdiction, select Third Circuit.
- 4. Under Category, select Cases.
- 5. Run the following search: **antitrust and chocolate and conspiracy**.
- 6. Use the *Timeline* on the left to filter your results by date: September 1, 2015 September 30, 2015.

On what date was the complaint filed in the U.S. District Court for the Southern District of Texas?

- 1. Sign into Bloomberglaw.com
- 2. In the top left corner, select Browse All Content.
- 3. Select Litigations & Dockets.
- 4. Select Dockets Search.
- 5. Next to Courts, type southern district and then scroll to find and select U.S. District Court for the Southern District of Texas.
- 6. In the Party Name field, type: **Greer** and from the "Any Type" drop-down select *Plaintiff*.
 - In the Date field, put the following date range: 1/1/2007 12/31/2007
 - Run the search.



On Valentine's Day 2013, Tiffany's filed a lawsuit against Costco for trademark infringement after it was discovered that Costco employees were referring to diamond rings sold by Costco as "Tiffany" rings. Find the August 2017 New York Times article discussing the outcome of the lawsuit and provide the name of the judge that ruled in favor of Tiffany's.

- 5. In the Search this title search bar, run the following search: **romantic gifts**.







In August 2010, New York became the last of the 50 states to enact no-fault divorce. What's the citation to the New York Session Law enacting no-fault-divorce and when did the new law take effect?

- 1. Sign into Westlaw.
- 2. From the Browse menu, select Proposed & Enacted Legislation.
- 3. Select New York.
- 4. Select New York Historical Session Laws under Tools & Resources on the right.
- 5. Run the following search: "no-fault divorce"

A number of Match.com customers filed suit against the online dating service for breach of contract, claiming that over half of the profiles belonged to inactive members or were fake. In which U.S. District Court was this 2012 case filed in?

- Go to Fastcase by selecting Fastcase from the Electronic Resources quadrant drop-down menu.
- 2. On the left side, select Advanced Caselaw Search.
- 3. Be sure that "Keyword Search (Boolean)" is selected.
- 4. In the search box type: Match.com & breach /2 contract.
- 5. Under "Select Jurisdictions" select All District Courts.
- 6. Under "Search Options" select the following date range: January 2012 December 2012
- 7. Search
